10.1 **SELGA President's Report**

Mayor Sage highlighted the importance of ensuring the region has close connection with the LGA SA and the range of meetings and initiatives that engage councils at a State level. It is important that councils are aware of the initiative regarding growing capacity in regions through employment, and can direct how this is achieved, particularly through the investment in infrastructure and use of local contractors.

10.2 **SELGA Executive Officer's Report**

Ann Aldersey highlighted three further items in addition to the written report:

- 1. Primary Industries and Regions is coordinating regional efforts to prepare and respond to potential dry climatic conditions during spring 2015 and beyond. Local Government has an important role to play in supporting community and government initiatives.
- 2. The region is hosting a Meet the Buyer event, in partnership with the Office of the industry Advocate. The event is to bring together State and Local Government procurers with local suppliers and contractors, to encourage local competitiveness with government tenders.
- 3. Following the meeting to coordinate preparation to host incoming trade delegations, a Working Party has been formed. The Working Party will provide an update to the Limestone Coast Economic Diversification Group on Friday 21st August, and will meet on Wednesday 26th August. The region will work with the LGA SA in the preparation of protocols to assist intra and inter regional communication and preparation.

10.3 Local Government Association of SA

Lisa Teburea, Director Planning and Development, highlighted a number of items:

- 1. The LGA SA has appointed a new CEO, Mr Matt Pinnegar, who will commence on 7th September 2015.
- 2. The LGA will be coordinating regional consultation on the planning reform legislation, in partnership with Wallmans Lawyers.
- 3. The LGA SA is preparing for the incoming trade delegation from China in September, and a China Engagement Strategy.

10.4 Office of Local Government

Ms Alex Hart, Acting Manager Office of Local Government with the Department of Planning, Transport and Infrastructure provided an update:

- Minister Brock has introduced the Local Government (Accountability and Governance) Amendment Bill 2015 into parliament for debate in September.
- 2. There is a review of the legislation and regulation governing Local Government elections, which includes release of information regarding political affiliations and Elected Member Code of Conduct.
- The Office of Local Government is currently considering boundary reform issues and delivery of regional services through legislative reform. The OLG is working with the LGA SA, with a view to introducing new legislation next year.
