1. Annual General Meeting

3. Recommendation Reports

- **3.1** The Substance Misuse Limestone Coast Committee requested the LCLGA become the custodian of the program to ensure regional delivery. The board supported the request until 30th June 2019 and subject to funding for the following financial year.
- **3.2** The board agreed to advocate for the universal use of "Limestone Coast" rather than "South East". Formal correspondence will be sent to government agencies requesting the adoption.
- 3.3 The Independent Commissioner Against Corruption (ICAC) has been invited to conduct a forum in the Limestone Coast for elected members and regional councils. The forum will include presentations from the Ombudsman Mr Wayne Lines & Auditor- General Mr Andrew Richardson. A date and venue are to be finalised.
- 3.4 The LCLAG Board will to conduct a workshop with the Waste & Resource Recovery Infrastructure project consultants to ensure a sound understanding of the report findings. A date and venue is being arranged.

4. Points of Interest

- **4.1** The LCLGA Board will facilitate a joint board meeting with Regional Development Australia Limestone Coast, to discuss common areas of opportunity.
- 4.2 The LCLGA was successful in receiving a \$30k grant from the Natural Disaster Resilience Program (NDRP). This funding will be utilised to develop flood mapping with 6 flood scenarios and erosion assessment of priority settlements on the Limestone Coast.
