  - LC LGA is concerned that the timing of the debate on the Planning, Development and Infrastructure Bill 2015 provides very little opportunity for Local Government and the community to provide meaningful input into any discussion.



- (ii) Neither has there been an appropriate consideration and modelling undertaken on the proposed amendments and the potential impacts this may have on the operation and functionality of Local Government and the repercussions this may have for the community.
- (iii) In particular LC LGA requests confirmation if:
  - financially modelling has been undertaken to identify the cost and nature of costs of implementing the bill.
  - It has been identified as to who is responsible for the costs of implementing the bill. It has been advised that the State Government will be seeking Local Government funding to implement and fund the initial establishment and ongoing costs of some initiatives being developed.
  - modelling has been undertaken to identify the appropriate resources required to implement the changes identified within the Bill. Has the State Government identified the level of resourcing required to implement the Planning Reforms and will the State Government allocate appropriate resources towards the implementation of the proposed Planning Reforms and ongoing operational costs.
- (iv) The Bill proposes a very different scenario for the role and involvement of Local Council's and the community in the Planning system and no opportunity has been provided to determine the impact this will have on Local Government from political, operational, financial and human resource perspectives. There have been a number of legislative amendments recently proposed by the State Government which when considered together provide for a very different environment within which Local Government will be required to operate.
- (v) In Conclusion, LC LGA requests that there is adequate time to facilitate a robust discussion and meaningful debate with all affected parties on the merits of the proposed bill so as to achieve the best outcome for the future development of South Australia.

Members may be aware that the Minister for Road Safety, the Hon Tony Piccolo, MP has been conducting a number of consultative forums associated with the review of rural speed limits. At this time the Minister has set aside the evening of Wednesday 25<sup>th</sup> November, 2015 to conduct a forum in the Limestone Coast. The format for the forum will include presentations from the Minister, the Department of Planning Transport and Infrastructure, SAPOL, Motor Accident Commission, the Centre for Automotive Safety Research and the RAA. This forum will provide Members with the opportunity to have their input on the review of rural speed limits within the Limestone Coast specifically.

Recent forums in other regional areas have run for a duration of between two to three hours.

The presentations focus on the history of the rural speed limit review, facts about roads and crashes, facts and science around speed limit setting and SAPOL experiences.
